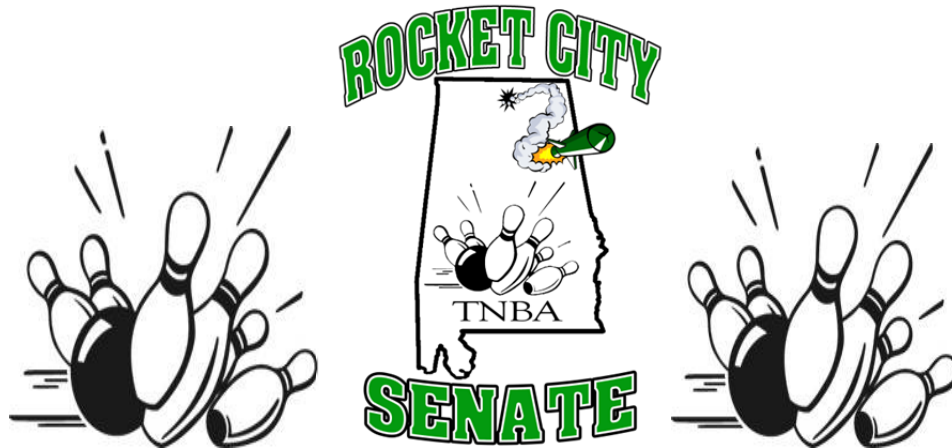

DOUBLES TOURNAMENT RULES

READ THESE RULES AND REGULATIONS CAREFULLY – FAILURE TO READ IS NO EXCUSE

1. This is a certified tournament governed by TNBA, USBC Rules and Regulations.
2. This tournament is Any Mix Doubles Tournament open to all bowlers who are current members of TNBA and USBC. Non-USBC members may enter by paying an unattached USBC membership fee of \$21 (\$10 National, \$10 Local & \$1.00 State). Non-TNBA members may enter by paying an unattached TNBA membership fee \$20.00 (\$14.00 National & \$6.00 for Local).
3. Teams will consist of two (2) members, any combination. Teams will bowl 3 games on the same pair of lanes.
4. Multiple entries are allowed. There will be Alibis. Team may cash only once with the same team members.
5. Substitutions are permitted upon notification. All substitutes must meet the same eligibility requirements as the bowler being replaced.
6. Entering average shall be the bowler’s highest 2010-2011 book average. If a bowler does not have a 2010-2011 book average, the bowler may use his/her highest summer average of 21 games or more as of July 1, 2011 or highest winter average as of January 1, 2012 with verification of average at the time of bowling. All others will bowl scratch with an average of 210. If current season average for at least 21 games exceed last season by 10 or more pins current season average must be used. The ten-pin rule is in effect (Rule 319a, Item 2). All averages will be verified at registration.
7. It shall be each bowler's responsibility to verify the accuracy of his/her average whether originally submitted by the bowler or others. Failure to use the proper average disqualifies score if submitted average is lower than actual, thereby resulting in lower classification or more handicap, or base prize winnings on submitted average if it is higher. This rule will be strictly enforced.
8. Handicap for men is 90% of the difference between 220. Handicap for women is 100% of the difference between 220. Handicaps will be figured individually for each bowler. Maximum handicap is 90.
9. Entry fee shall be \$50.00 Per Team. (\$30.00 Prize Fund, Lineage/Expenses \$20.00) Prize fund should be returned 100% to bowlers. Prizes are payable at a ratio of at least 1 out of every 10 entries. **NO PERSONAL CHECKS WILL BE ACCEPTED.** Make Cashier’s Check/Money Order payable to Rocket City Senate.
10. Pre-entries deadline is January 21th, 2012.
11. No entry will be accepted without entry fee. Incomplete entries will be returned.
12. Entries close 30 (thirty) minutes before start of scheduled squad time printed on tournament form.
13. USBC rule 319D is in effect for all USBC members. Bowlers, who have qualified for a prize fund of \$600.00 or more in any event in a tournament which has ended within the previous 12 month period, even though payment of prize has not been made, must report actual score, position and amount won for possible re-rating. Failure to comply with either of these provisions shall be cause to forfeit tournament entry fee and prize winnings. All participants must be familiar with rule 319E – Average adjustment-the average of a bowler may be adjusted before the entrant bowls. If the bowler does not accept the assigned entry fee will be refunded. This applies to all participants.
14. Tournament Director reserves the right to add additional squads during the course of the tournament with available lanes. No squads may be added after the final advertised squad on January 29, 2012 @ 3:00 P.M.
15. Tardy bowlers will start in frame being bowled with zero 0 given in frame missed.
16. All protests are to be registered with the Tournament Director. The Tournament Director and committee will decide upon any rule not covered herein by TNBA, USBC rules. The decision of the Tournament Director and Committee shall be final unless appealed in accordance with Rule 329. Money will be distributed within 30 days after the close of tournament, unless there is a protest pending. Premature Termination of the Tournament brought on by any reason beyond the control of the Rocket City Bowling Senate of TNBA shall cause, to extent required thereby, all prizes to be prorated in accordance with the number of entrants who have bowled up to the time of such termination.
