# ***ROCKET CITY SENATE TOURNAMENT***

## **TOURNAMENT RULES AND REGULATIONS**

1. This tournament is open to all TNBA members, except for professional bowlers. It will be operated under the tournament rules of TNBA and USBC. All entrants must have current TNBA and USBC membership cards prior to bowling. TNBA membership cards may be purchased on site at a cost of \$21.00 each.
2. Pre-entries deadline is July 26, 2022, and the full amount of fees must accompany the entry for same to be honored. Entries postmarked the 1st post office business day following the entry closing date shall be accepted.
3. Personal checks **will not** be accepted for any reason. The total entry fee shall be in the form of Money Order, Cashier or Certified Check, must accompany the application, and made payable to the Rocket City Senate.
4. Entry forms must be filled out in their entirety. First and Last names (no nicknames), address, TNBA & USBC numbers and an average for each bowler.
5. This is a double/alibi format tournament, with a option for singles. Doubles will consist of any combination of male and/or female. An alibi, is bowling with another person during a prepaid entry for an additional fee and those scores will count for the tournament. Multiple partners are encouraged but can only cash once with the same partner. Bowlers will bowl 3 games on the same pair of lanes. If entering optional singles, your double scores will count as your single score.
6. ENTRY FEES: The entry fee is \$35 per person. Alibi doubles fee is \$10 per person (\$20 per team). 100% of the prize funds collected from doubles, optional singles, and/or alibis will be combined and disbursed according to doubles/single placements.
7. Walk-ins are welcomed, based on lane availability. Entries close 30 minutes prior to the squad time. The entry fee must be paid in full prior to the start of practice. ALIBI FEES will be collected until the start of tournament play.
8. AVERAGES: Bowlers will use their highest certified league average consisting of at least twenty-one (21) or more games for the 2020-2021 winter season. If a bowler does not have a 2020-2021 average, bowlers must use their highest 2019-2020 winter season average consisting of at least twenty-one (21) or more games. Bowlers without a 2019-2020 average or 2020-2021 average must use their highest average for the 2021-2022 winter season consisting of at least twenty-one (21) or more games, at the time of bowling. 2021-2022 winter league standing sheets must be presented upon check-in. Bowlers who do not meet any of the average requirements will be entered with a 220 average.
9. The USBC 10 pin average rule **does not** apply.
10. Handicap for each game shall be 90% of 220.
11. The Tournament Management reserves the right to disqualify any entrant not in compliance with the rules of the tournament, TNBA and USBC.
12. It is the bowler's responsibility to check their scores after each game.
13. Tardy players will start in frame being bowled with zero being given for each frame missed. If a team refuses to start because a full lineup is not present, they shall receive zero for all frames which they decline to bowl. No blind score shall be permitted, and a bowler must bowl with and on the same lanes and at the same time his/her team bowls.
14. After entry has been received, no fees shall be refunded except in dire emergency such as strikes, lockouts, fires, etc., over which management has no control.
15. Championships will be determined by the greatest total of pin fall and handicap. There will be at least one prize for every eight (8) entries. Prize fund checks must be cashed in 90 days; or will be voided. Prize checks will be distributed within 30 days after the conclusion of the tournament.
